



MASCOT Boilersuit Akron

Triple stitched seams on the sleeves, shoulders, leg and crotch. Ergonomically formed trouser leg. Fastening with two way zip, storm flap and press studs. High collar. Chest pockets with flap and hidden press studs. D-ring. Front pockets. Access to trousers from both sides. Back pockets with flap and hidden press studs. Thigh pocket with flap and hidden press studs. Rule pocket. Cuffs with press stud fastening. Elastic and pleat in the back. Adjustable knee pad pockets. Contrast stitching. Tested in accordance with EN/ISO 15797 and assessed according to ETSA .
